The approach is based on 12 core components that provide a foundation for how the work is carried out with families and at the system level. It has been recognized by the California Evidence-Based Clearinghouse for Child Welfare as demonstrating promising research evidence and is a program under the ZERO TO THREE National Infant-Toddler Court Program (ITCP). The ITCP is working to support the implementation of this approach in over 70 sites across the United States and have several that are adopting it statewide.

Choptank B Digital Transformation of Society Presenter: Jack McCarthy III

Over the past thirty years, the New Jersey Judiciary built one of the most comprehensive judicial information systems in the country. Every court case type has been automated. The automated systems establish the official court records and dockets for more than seven million cases per year. We have reflected and incorporated legislative and court rule changes, interfaced with law enforcement and other government agencies, and enabled the legal community, media and many others to access our information online through our online electronic public access service. In providing technological solutions, the judiciary focuses on delivering business value while driving toward a complete digital transformation of the organization. This transformation is built on four foundational pillars where we digitize documents, decisions, processes and the customer experience and leverage the insights gained by analyzing the derived data to create significant efficiencies. Jack McCarthy will discuss some of the new technologies that the judiciary is working on and their impacts on our work as well as society.

Choptank C Rethinking Guardianship: How Strategic Partnerships Advance Reform Presenter: The Honorable Karen Murphy Jensen, Nisa Subasinghe

In anticipation of the increase in the aging population, and the attendant rise in guardianships, Maryland's Chief Judge made guardianship reform a priority. The Maryland Judiciary's Guardianship & Vulnerable Adults Workgroup, an interdisciplinary network of guardianship stakeholders, is working to adopt best practices statewide. An area of improvement the workgroup identified is how courts support family guardians. Problems occur if guardians do not understand their role or are unaware of available resources. Guardians are also in a unique position to identify, stop, and prevent abuse, neglect and exploitation. Since the court is the ultimate guardian, it is important for courts to equip guardians with the information and tools they need to be successful. Panelists will discuss Maryland's approach to guardianship reform and resources developed to support family guardians. Attendees will learn how a framework of strategic collaboration can be applied to address many complex reforms and receive practical guidance on how to define a problem, convene and manage guardianship stakeholders, and use available resources to effect meaningful change.

Cutter Management by Walking Around (MBWA) Presenter: David Beverly

Management by Walking Around (MBWA) often viewed as an unstructured approach to hands-on, direct participation by the managers in work-related affairs a contrast to rigid and distant management. In MBWA practice, managers spend time making informal visits to the work area and listening to the employees. The purpose of face-to-face visits is to collect qualitative information, listen to suggestions and complaints, and keep a finger on the pulse of the organization. Today we can also 'walk around' via technology, including off-site work teams etc. During this workshop, we will explore forms of management communication, and the various approaches to MBWA. We will also help you review what you can do to individualize for your team or organization.

Windjammer Resolution Support Centers Presenter: Ken Jandura

We live in a period where self-help services have become a norm for most Americans. Self-help centers are appearing in courthouses across the country today with the intent of helping individuals navigate through the complexity of our legal system and avoiding time delay once their case reached court. The purpose of this seminar is to discuss innovative ways court systems have designed and implemented resolution support centers in the states and internationally, and how they can benefit the community and judiciary in handling their caseload. The seminar will also discuss unique architectural features that make these centers successful and how they can be implemented in existing or proposed court facilities that present an image of a justice center that is truly a community building.

Skipjack Mediating Cases with Intimate Partner Violence Presenters: Jeannie Adams, Shavon Brooks

Over half of separating parents report some type of intimate partner violence (IPV) (IPV; Ballard et al., 2011). Litigation of these cases may exacerbate parental conflict, mediation is designed to decrease conflict and empower parties to self-determine outcomes. Critics argue that mediation is not appropriate for cases with IPV, as power imbalances may lead a victim to make agreements that are not in their best interests. Others argue that mediation can be designed to be safe for such cases. There is no systematic way of handling IPV in family mediation and no previous research addressing this issue. The Multi-Door Dispute Resolution Division of the DC Superior Court collaborated with experts in the field of domestic violence and designed a study, funded by National Institute of Justice and supported by the Office of Violence Against Women and the Battered Women's Project. This session will discuss the collaboration/partnership with experts in domestic violence, stakeholder engagement, the screening process used to detect IPV, the study design, safety protocols, training of staff and mediators, mediation processes designed to accommodate these cases, immediate outcome data and what we learned.

Cutter Implicit Bias; Unconscious Bias

In this session, we will explore the characteristics of implicit biases. Implicit bias refers to the attitudes or stereotypes that affect our understanding, actions, and decisions in an unconscious manner. These biases, which encompass both favorable and unfavorable assessments, are involuntarily and without an individual's awareness or intentional control. Residing deep in the subconscious, these biases are different from known biases that individuals may choose to conceal for the purposes of social and/or political correctness. Rather, implicit biases are not accessible through introspection. The implicit in our subconscious cause us to have feelings and attitudes about other people based on characteristics such as race, ethnicity, age, and appearance. These associations develop over a lifetime beginning through exposure to direct and indirect messages. Media and news are often origins of implicit associations.
